The framework agreement has been let without Lots, but all suppliers were asked to confirm and have been appointed to the framework based upon the regions they would cover from:

- North East
- Yorkshire and Humberside
- Midlands
- Wales
- South West
- South East and London
- East Anglia

The suppliers are appointed to the framework agreement in ranked order.

SCOPE

The framework agreement covers the purchase of:

- i. personal paper products
- ii. cleaning and janitorial carts and accessories
- iii. waste containers and accessories
- iv. cleaning equipment*

* NB - The scope of the framework agreement does not include mechanical or electrical cleaning equipment; this is covered by a separate framework agreement that is led by NWUPC. The cleaning equipment referred to above is dusters, squeegees, scrapers etc

- v. cleaning equipment accessories
- vi. cleaning rags, cloths and wipes
- vii. brooms, mops, brushes and accessories
- viii. cleaning and disinfecting solutions
- ix. absorbents
- x. cleaning kits
- xi. restroom supplies

AGREEMENT BENEFITS

- BT1/BT2 cash savings will be reportable once the new framework is implemented, the level of this will be determined by the final pricing submissions from the winning bidders.
- BT3 savings may be reported for all members using the agreement for the first time.
- There is potential for BT14 non-cash savings to be reported through this framework due to the sustainability element in the ITT

USING THE FRAMEWORK

Users should in the first instance read through the Buyer's Guide to confirm this agreement is suitable for their use. The framework allows a direct award to the number 1 supplier on the contract for the appropriate regions. There are three further options to call-off/award: desktop exercise, further competition and competitive quotation.
